NICE GUIDANCE PH48 TOOLKIT DOCUMENT 7: ASSESSMENT & EVALUATION

Implementing a successful Smokefree policy is complex, as is assessing efficacy of the measures taken to implement. Strong on-going commitment is vital to maintain and reinforce progress, and bring about the cultural change necessary.

Implementing a successful Smokefree policy will take time to embed, and requires input from a range of partners. When the policy is initially implemented, it will require ongoing work from the Trust to maintain a high level of compliance. Therefore, the Trust will need resources for assessing the efficacy of the policy.

This section of the Toolkit aims to provide some essential measures Trusts should take to provide evidence of success. In addition there are suggested local measures which can help provide a more complete picture, thus informing practice and highlighting areas for development.

NATIONAL MEASUREMENTS

CLeaR Deep Dive on Acute and Maternity Settings – recommended to be completed biennially

CLeaR is a system led improvement tool for tobacco control, initially developed by ASH and partners, and now managed by PHE. It enables localities to score themselves against established standards of good practice such as NICE guidance. It is designed to highlight strengths and areas for development, to inform local improvement plans.

The original **CLeaR** tool covered the breadth of tobacco control work, but a review in November 2017 created additional "deep dive" tools to look in more detail at specific elements of tobacco control, namely:

- Smoking & pregnancy
- Smoking & mental health,
- Smoking and acute settings
- Tackling illicit tobacco

It is recommended that **ALL** Trusts use the appropriate tool which can be accessed below looking for the link as highlighted. The accompanying Power Point presentation provides more detailed explantion. An example of the spidergraph which the tool will enable Trusts to produce is also provided.

NATIONAL COUIN – PREVENTING ILL HEALTH THROUGH RISKY BEHAVIOURS – REPORTING COMPLETED QUARTERLY

National CQUIN targets are set to measure smoking interventions by recording Very Brief Advice (VBA). This evidence-based approach as recommended by NICE can take as little as 30 seconds and consists of three A's namely:

Ask – and record smoking status

Advise – the best thing to do is stop smoking, the best way to do that is

through support from stop smoking services

Act – on the response to advice given and arrange medication for

temporary abstinence and referral

The table below provides a list of measures which all help to build a picture of the impact and effectiveness of implementing a Smokefree policy. It is acknowledged that feasibility of reporting on these measures will be dictated by the availability of systems which can effectively collect the data needed.
